

## Accreditation Visits Scheduled for Fall 2009

As required by the United States Department of Education, this serves as notice to the public of upcoming accreditation visits and the opportunity for written third-party comment. Written comment concerning accreditation qualifications for the institutions or programs listed below (i.e., determining whether a program appears to be in compliance with Accreditation Council for Occupational Therapy Education [ACOTE®] accreditation standards or ACOTE accreditation policy) may be submitted ***no later than 20 days prior to the program's scheduled on-site evaluation*** to Sue Graves, Assistant Director of Accreditation, AOTA, 4720 Montgomery Lane, P.O. Box 31220, Bethesda, Maryland 20824-1220.

Receipt of the third-party comment will be acknowledged, a copy of the comment letter will be sent to the relevant program director, and the third-party comment will be processed according to current ACOTE policy.
