RE: Immediate Action to Address the Medicare Part B Therapy Caps

Dear Leader McConnell, Speaker Ryan, Leader Schumer, and Leader Pelosi:

Representing the concerns of Medicare beneficiaries, health care professionals and providers, the undersigned organizations strongly urge the House and Senate to take action before the end of the year to permanently address the Medicare Part B therapy caps. Access to critical rehabilitation services for Medicare beneficiaries suffering from stroke and other health conditions is at stake if the House and Senate fail to act before the end of the year.

Bipartisan efforts in the House Ways and Means Committee, House Energy and Commerce Committee, and Senate Finance Committee have achieved a policy that would permanently end arbitrary limits on beneficiary access to necessary physical therapy, occupational therapy, and speech language pathology services; after 20 years, the therapy cap would no longer threaten beneficiary access to necessary therapy services. The Committees have worked in concert with beneficiaries, health professionals and providers to achieve this goal. It is a substantial achievement after years of toiling on this issue.

As leaders of the House and Senate we urge you to advance this legislation before the end of the calendar year. The therapy cap would limit treatment options for millions of Medicare beneficiaries when the cap is reinstated on January 1, 2018. At a minimum, we ask that the House and Senate include language in the upcoming Continuing Resolution to ensure a short-term gap of coverage does not occur until a permanent solution can be enacted. This would protect beneficiaries who might quickly exhaust their outpatient therapy benefit.
