

## Accreditation Visits Scheduled for Winter-Summer 2018

As required by the United States Department of Education, this serves as notice to the public of upcoming accreditation visits and an opportunity for written third-party comment. Written comment concerning accreditation qualifications for the institutions or programs listed below (i.e., determining whether a program appears to be in compliance with Accreditation Council for Occupational Therapy Education [ACOTE®] accreditation standards or ACOTE accreditation policy) may be submitted **no later than 20 days prior to the program's scheduled on-site evaluation** to: Director of Accreditation, AOTA, 4720 Montgomery Lane, Suite 200, Bethesda, Maryland 20814-3449. Per ACOTE's [Policy on Third-Party Comment](#), AOTA accreditation staff will acknowledge receipt of the third-party comment and will copy the letter of comment to the relevant program director and on-site evaluation team. The individual making the third-party comment may request in writing to remain anonymous. AOTA staff will redact personal information contained within the document prior to forwarding the comment to the program director and the on-site evaluation team.
