

## Accreditation Visits Scheduled for Fall 2017

As required by the United States Department of Education, this serves as notice to the public of upcoming accreditation visits and an opportunity for written third-party comment. Receipt of a third-party comment will be acknowledged and processed according to ACOTE's [Policy on Third-Party Comment](#), which includes sending a copy of the comment letter to the director of the occupational therapy or occupational therapy assistant program named in the letter.
